
RESOLUTION NUMBER R- 273713

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to employ ANDREW A. SMITH, MAI, HILLIARD L. LIPMAN, MAI, and GLENN M. DESMOND, MAI, Independent fee appraisers, to appraise the proposed East Broadway Civic Center Project, under the terms and conditions of those letter proposals collectively on file in the office of the City Clerk as Document No. RR- 273713.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$100,000 from C.I.P. 37-220, Civic Center Complex, to cover costs of two independent fee appraisals and a goodwill appraisal for the proposed East Broadway Civic Center Project, including a valuation of fixtures and equipment, is hereby authorized and approved, said funds, plus eight (8) percent simple interest, to be reimbursed to the Water Utilities Department from any available City funds in the event the project, now in a conceptual state, does not ultimately proceed to construction within ten (10) years.
