

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and directed to execute said agreement for and on behalf of The City of San Diego.

BE IT FURTHER RESOLVED, that the City Council hereby approves the nomination of the Councilmembers from Council Districts 1 and 2, to serve as primary representative to the San Dieguito River Valley Regional Open Space Park Joint Powers Authority, and the Councilmembers from Council Districts 3 and 4, to serve as their respective alternates to said Authority.
