

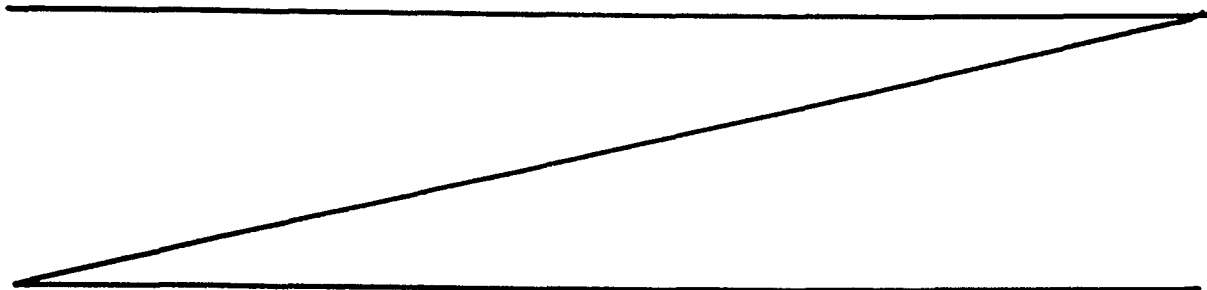
RESOLUTION NUMBER R- 273718

BE IT RESOLVED, by the Council of The City of San Diego, that the City Council hereby approves the establishment of the San Dieguito River Valley Regional Open Space Park Joint Powers Authority, in accordance with the terms and conditions of the Joint Exercise of Powers Agreement among the County of San Diego and the cities of Del Mar, Escondido, Poway, San Diego and Solana Beach, a copy of which is on file in the office of the City Clerk as Document No. RR- 273718 .

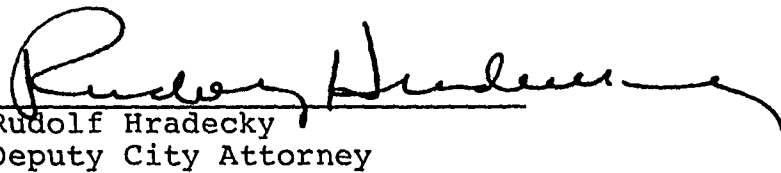
BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and directed to execute said agreement for and on behalf of The City of San Diego.

BE IT FURTHER RESOLVED, that the City Council hereby approves the nomination of the Councilmembers from Council Districts 1 and 2, to serve as primary representatives to the San Dieguito River Valley Regional Open Space Park Joint Powers Authority, and the Councilmembers from Council Districts 3 and 4, to serve as their respective alternates to said Authority.



BE IT FURTHER RESOLVED, that such primary and alternate representatives and their duly elected or appointed successors shall serve on the Authority at the pleasure of the City Council.
