
ADOPTED ON JUN 12 1989

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$20,000 from Fund No. 65013 is hereby authorized, solely and exclusively for the purpose of providing funds for the above Retainer Agreement.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to remit unexpended funds, if any, to the appropriate reserves upon advice of the administering department.
