BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer within Capital Outlay Sales Tax Fund 30245 an amount not to exceed \$7,500 from CIP 52-383.0, Jackson Drive Extension Study to CIP 52-431.0, Jackson Drive Extension to SR-52; and within Proposition A  $\frac{1}{2}$ % Sales Tax Fund 30300 an amount not to exceed \$117,500 from CIP 53-046.0, Friars Road Bridge to CIP 52-431.0, Jackson Drive Extension to SR-52.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$125,000 from CIP 52-431-0, Jackson Drive extension to

SR-52, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
