WHEREAS, the California State Assembly approved a \$5.79 million budget augmentation to fund the lease of property in Otay Mesa and develop an offroad vehicle park; and

WHEREAS, at the Rules Committee meeting on June 7, 1989, the City Manager and the Intergovernmental Relations Department expressed their concerns about the effect of such land use on proposed projects of surrounding jurisdictions; and

WHEREAS, the City Council has declared a state of emergency in San Diego relating to gang violence and drugs; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Intergovernmental Relations Department be and it is hereby directed to oppose the appropriation of \$5.79 million for purposes of an offroad vehicle park and to explore obtaining this funding for the City's priorities related to gang violence and drugs as listed in the City Council's declaration of a state of emergency.

BE IT FURTHER RESOLVED, that the Director of Intergovernmental Relations Department have the City's Sacramento representative inform state legislators of the City's concern.
