VACATION OF "C" STREET BETWEEN
INDIA STREET AND KETTNER BOULEVARD.

WHEREAS, it is proposed that "C" Street Between India Street and Kettner Boulevard be vacated; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation or abandonment is not inconsistent with the General Plan or an approved Community Plan; and


WHEREAS, the public street system for which the right-of-way was originally acquired will not be detrimentally affected by this vacation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, California, that "C" Street between India Street and Kettner Boulevard, as more particularly referred to in Resolution of Intention No. R- 273477, is found to be no longer necessary for public street purposes.

BE IT FURTHER RESOLVED, that "C" Street, as more particularly shown on Drawing No. 17428-B, on file in the office of the City Clerk as Document No. RR- 273477, which said Drawing is attached hereto and made a part hereof, be, and the same is hereby ordered vacated.

BE IT FURTHER RESOLVED, that the City Clerk shall cause a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.

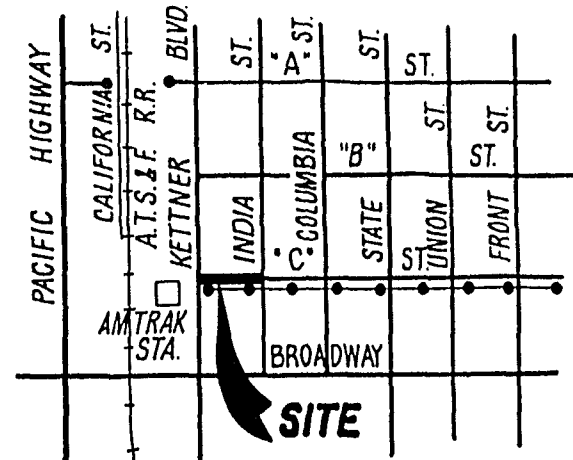

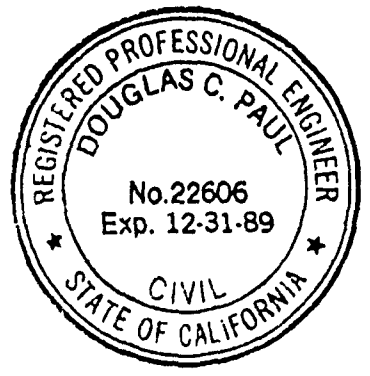
