ADOPTED ON JUN 19 1989

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized to increase the cost to seniors participating in the City sponsored nutrition program operated by the San Diego Unified School District from one dollar (\$1) to one dollar and twenty-five cents (\$1.25).

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, thirty-five (35) agreements with community agencies to operate social service programs during fiscal Year 1990 at the funding levels recommended by the Public Services and Safety Committee on May 31, 1989, under the terms and conditions set forth in the Agreements on file in the office of the City Clerk as Document Numbers as follows:
