
ADOPTED ON JUN 19 1989

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$35,000 from Fund 18524, Dept. 5666, Org. 6602, is hereby authorized solely and exclusively for the purpose of providing funds for the above project.
