RESOLUTION NUMBER R- 273802

ADOPTED ON JUN 19 1989

WHEREAS, H.R. 2265 has been introduced to amend the Internal Revenue Code of 1986 to exclude from gross income the value of certain transportation furnished by an employer, which, if enacted, would provide additional incentives for employers and employees to use alternate forms of transportation to travel to and from work; and

WHEREAS, The City of San Diego is in the process of developing a transportation plan seeking to reduce dependence upon demand for municipal facilities and services involved in the utilization of private vehicles; and


WHEREAS, the City's efforts in this regard would be enhanced by the passage of federal legislation seeking to create such incentives; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Council hereby authorizes the Director of the Intergovernmental Relations Department to communicate with the appropriate legislative officials of the federal government the City of San Diego's support of H.R. 2265.

BE IT FURTHER RESOLVED, that the City Council hereby authorizes the Director of the Intergovernmental Relations Department to seek an amendment to H.R. 2265 to add an inflation factor or specify an annual increase in the dollar amount of the

monthly benefit in order to provide for subsequent inflationary increases in the cost of transportation benefits provided by employers.
