BE IT RESOLVED, by the Council of The City of San Diego, that the SANDAG Board and the Regional Transportation Commission are hereby requested to:

1. Designate Jackson Drive as an arterial road in the City of San Diego and its connection to SR-52, as an interchange, as an integral part of the SR-52 project;

2. Confirm that the SR-52 project includes the Jackson Drive interchange, and associated environmental mitigation costs which are to be funded as part of the SR-52 project costs by Proposition A State Highway Funds; and

3. Include the Jackson Drive interchange in the SR-52 freeway project prior to an adopted agreement being signed by The City of San Diego.
