WHEREAS, on Tuesday, June 13, 1989, the Council voted to reconsider docket item S406 from the previous day's agenda; and


WHEREAS, under the Ralph M. Brown Act, reconsideration was improper at that time; and

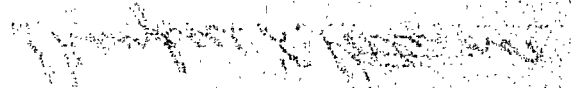
