WHEREAS, the matter is now forwarded to the full Council with a recommendation to approve said additional year of personal services; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a Personal Services Agreement with JOHN H. MONTGOMERY and JOHN R. O'DONNELL, for Washington, D.C. representation, for the period July 1, 1989 through June 30, 1990, under the terms and conditions set forth in the Personal Services Agreement, on file in the office of the city Clerk as Document No. RR- 273807.

BE IT FURTHER RESOLVED, that the Council of The City of San Diego hereby expresses their appreciation to John R. O'Donnell and John H. Montgomery for the excellent job they do on behalf of the City.
