RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO, COUNTY OF SAN DIEGO, CALIFORNIA DETERMINING UNPAID ASSESSMENTS AND THE MANNER OF PAYMENT THEREOF AND LISTING BONDS ISSUED ON THE SECURITY THEREOF.

Assessment District No. 4029

(Sorrento Valley Road - Sorrento Valley Boulevard to I-805)

WHEREAS, this City Council has taken proceedings under the Municipal Improvement Act of 1913, Division 12 of the Streets and Highways Code (the "Code") and has confirmed an assessment within Assessment District No. 4029, which assessment and an assessment diagram were duly recorded in the office of the Superintendent of Streets; and

WHEREAS, a copy of the assessment diagram, a notice of assessment, and a list of the owners of property assessed were duly recorded in the office of the County Recorder of San Diego County in the time and manner required by law; and

WHEREAS, a Notice of Recordation of Assessment was published and mailed to the owners of the property assessed in the time and manner required by law; and

WHEREAS, the Resolution of Intention, Resolution No. R-273086, adopted by this Council provided that bonds would be issued pursuant to the Improvement Bond Act of 1915, Division 10 of the Code; and
