WHEREAS, the Spreckels Organ Society will inaugurate the 1989 Summer Monday Evening Concert Series of the Spreckels Organ in Balboa Park on June 26, 1989; and

WHEREAS, the Spreckels Organ is the world's largest outdoor musical instrument, donated seventy-four years ago for the free attendance and enjoyment of the people of San Diego; and

WHEREAS, the Spreckels Organ Society has been operating for the past year to establish an endowment fund to insure the permanent financial security of the Spreckels Organ and to expand the use and appreciation of the Organ; and

WHEREAS, this year, the Spreckels Organ Society has raised \$50,000 to purchase the thirty-two foot Contra Bombarde to complete the Spreckels Organ; and

WHEREAS, the Council of The City of San Diego recognizes the importance of the Spreckels Organ and appreciates the benefit it provides to the citizens and visitors of San Diego; NOW,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of the people of San Diego, does hereby designate Monday, June 26, 1989 as "SPRECKELS ORGAN DAY."
