BE IT RESOLVED, by the Council of The City of San Diego that the low bids of 1. GTE MOBILE COMMUNICATIONS CORPORATION, 2. QUINTEX MOBILE COMMUNICATIONS and 3. U.S. WEST CELLULAR OF CALIFORNIA, INC., meeting specifications, are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of CELLULAR RADIO TELEPHONE EQUIPMENT AND SERVICE as may be required for a period of one (1) year beginning July 1, 1989 through June 30, 1990, per prices on file in the Purchasing Department, as follows:

1. GTE MOBILE COMMUNICATIONS CORPORATION for Section I, Item 1 - Portable (hand-held) Unit, OKI Model 700; Section I, Item 2 - Packset Unit NOKIA Model 412; Section I, Item 4 - Vehicular Mount Full Feature Unit, OKI Model 410; terms net 30 days, plus sales tax, with an option to renew the contract for an additional one (1) year period.
2. QUINTEX MOBILE COMMUNICATIONS for Section I, Item 3 - Vehicular Mount Standard Feature, Audio Vox Model BC-20; terms 2% 10 days, plus sales tax, with an option to renew the contract for an additional one (1) year period, option year increase not to exceed 10% of the original contract pricing.
3. U.S. WEST CELLULAR OF CALIFORNIA INC. for Section II - Cellular Service; terms Net 60 days, with an option to renew the contract for an additional one (1) year period.
