BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$15,361 from PSD Fund 16000 and \$37,639 from Fund 11730 to CIP No. 29-447 NESTOR NEIGHBORHOOD PARK - DEVELOPMENT.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer funds to meet the requirement that CIP No. 29-447 NESTOR NEIGHBORHOOD PARK - DEVELOPMENT be funded until grant monies are received from the State (\$33,000), from Park Service District Fund 16000 - \$33,000. At a later time, after funds are received, the department will return to Council with a request to reinstate funding to the Park Service District Fund from where money was transferred.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$801,222 (\$297,000 from 1984 State Bond Act Grant Fund 39039 and \$504,222 from Park Service District Funds) from CIP No. 29-447 NESTOR NEIGHBORHOOD PARK - DEVELOPMENT is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
