BE IT FURTHER RESOLVED, that the Mayor and the City Clerk are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a grant deed transferring said City-owned parcel, as more particularly described in that deed on file in the office of the City Clerk as Document No. RR-273855-2.
