
ADOPTED ON JUN 26 1989

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$32,000 from 1989-90 CDBG Fund 18525, Dept. 5885, Org. 8501, Job Order No. 008501, is hereby authorized solely and exclusively for the purpose of providing funds for the above project.
