

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$45,400 from Penasquitos Canyon Preserve Park Fund No. 10582 to CIP No. 29-428, Los Penasquitos Canyon.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$45,400 from CIP No. 29-428, Los Penasquitos Canyon Preserve, is hereby authorized, solely and exclusively for the purpose of providing funds for the above amendment.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to transfer excess budgeted funds, if any, to the appropriate reserves upon advice of the administering department.
