
ADOPTED ON JUN 26 1989

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to issue one check in the amount of \$500,000.00 made payable to Joanne, Stephanie and Mark Stevenson and James McIntyre their attorney, in full settlement of the lawsuit and of all claims.
