RESOLUTION NUMBER R- 273881

ADOPTED ON JUN 26 1989

WHEREAS, on June 26, 1989, the Council of The City of San Diego received the Intergovernmental Relations Department (IRD) No. 89-28 on AB 1999 (Farr) University of California and California State University: Growth; and

WHEREAS, the Council finds that AB 1999 (Farr) requires the University of California and the California State University systems to make a good faith effort to work with local planning groups and honor local planning priorities in planning for campus growth; and

WHEREAS, the Council finds that AB 1999 (Farr) requires that the State mitigate unrecoverable costs incurred by local agencies as a result of campus growth; and

WHEREAS, the Council finds that these requirements are consistent with the needs of The City of San Diego as a site of such institutions; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council approves the recommendation set forth in Intergovernmental Relations Department Report No. 89-28 to support AB 1999 (Farr).

BE IT FURTHER RESOLVED, that the Intergovernmental Relations Department is hereby directed to express the City's support to the appropriate state legislators and to the Governor.
