John Murrieta	Park & Recreation	\$2,256.92	Mr. Murrieta is a Lifeguard II. He suggested purchasing a Boston Whaler Boat instead of leasing one and do not perform repairs on Marines four and five. The actual savings are \$7,523.05 in leasing charges. This is his full award.
Meril Rangel	Park & Recreation	\$500.00	Mr. Rangel is a Grounds Maintenance Worker II. He suggested using anti-draft cyclinder when spraying chemicals. Although savings are difficult to identify, this was considered to be a significant operational improvement.
