German Gonzalez	Personnel	\$312.34	Mr. Gonzalez is an Associate Personnel Analyst. He suggested changing the format of employment newspaper ads. The actual savings are \$1,766.46 in ad charges. This is his full award.
Edwin Asuncion	Park & Recreation	\$280.00	Mr. Asuncion is a Grounds Maintenance Worker I. He suggested attaching a slinky to the top of light poles around multi-purpose courts. Although savings are difficult to identify, this was considered to be a significant operational improvement.
Paul Powell	General Services	\$160.00	Mr. Powell was a Building Maintenance Supervisor with the Buildings Division at the time of this suggestion. He suggested changing the FY 1982/1983 Organization Chart. Although savings are difficult to identify, this was considered to be a significant operational improvement.
Anthony DiLeva	Fire Department	\$90.00	Mr. DiLeva is a Firefighter. He suggested outfitting each company with an emergency escape pack. Although savings are difficult to identify, this was considered to be a significant operational improvement.
