Tony Padilla	Water Utilities	\$90.00	Mr. Padilla is a Equipment Technician I. He suggested the installation of an electric winch to lift the pump and bar rack in the influent area at Aqua II. Although savings are difficult to identify, this was considered to be a significant operational improvement.
James McCormick	General Services	\$84.23	Mr. McCormick was a Building Manager with the Buildings Division at the time of this suggestion. He suggested modifying the flag police lighting at the Central Police Station. Actual savings of \$280.75 was realized. This is his full award.
Maureen Dixon	Waste Management	\$52.80	Ms. Dixon is an Intermediate Typist II. She suggested establishing a fee to recover costs associated with processing the Hold Harmless agreements. Actual savings of \$176 was realized in cost savings. This is her full award.
Robert Hammond	Fire Department	\$45.00	Mr. Hammond is a Fire Engineer. He suggested changing the oil on small four-cycle engines bi-annually. Although savings are difficult to identify, this was considered to be a significant operational improvement.
