

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$15,000 from CIP No. 29-204.0, Murray Ridge Neighborhood Park Development, is hereby authorized, solely and exclusively for the purpose of augmenting expenditures previously authorized by Resolutions No. R-268924 adopted July 27, 1987, No. R-269713 dated November 16, 1987 and No. R-271903 adopted September 19, 1988.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to remit unexpended funds, if any, to the appropriate reserves upon advice of the Parks and Recreation Department.
