

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$102,700.00 from the Waste Management/Litter Control budget, Refuse Disposal Enterprise Fund, is hereby authorized, solely and exclusively for the purpose of providing funds for the above agreement.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to remit unexpended funds, if any, to the appropriate reserves upon advice of the appropriate department.
