
ADOPTED ON JUL 10 1989

BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of a grant deed of MALCOLM SWEET, EDWARD PERKINS, JOSEPH BARRY, DONALD J. DEVITT and ROBERT MCDONALD, Trustees of the Common Law Trust known as Pipefitters Welfare Education Fund and Pipefitters Pension Fund (Local 562), executed in favor of The City of San Diego, bearing date of May 11, 1989, a copy of which is on file in the office of the City Clerk as Document No. RR- 273947, granting to said City a portion of the West Half of Lot 4 of Section 27, Township 14 South, Range 3 West, S.B.B.M., for vernal pool preservation, as more particularly described in said deed, be and the same is hereby approved.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$455,000 from C.I.P. 391080, Vernal Pool Preservation Fund 10570, for the acquisition of the above described property and related costs, is hereby authorized and approved.

BE IT FURTHER RESOLVED, that the City Clerk is hereby authorized and directed to cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder at no fee for the benefit of the City, with no documentary tax due.
