BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to issue two checks, one in the amount of \$45,500.00, made payable to Faauma Maulupe, Asosa Maulupe, Noema Maulupe and their attorney Patrick L. McCrary; and a second check in the amount of \$5,000.00 made payable to the Clerk of the Superior Court in full settlement of all claims.
