RESOLUTION NUMBER R- 273957

ADOPTED ON JUL 10 1989

WHEREAS, on June 21, 1989, the City Council Committee on Rules, Legislation, and Intergovernmental Relations approved the concept of a State Fair Share Initiative by which a ten percent (10%) share of the state income tax would be distributed to all California cities and counties based on their percentage of total population of California; and

WHEREAS, such an initiative would provide The City of San Diego, as its pro rata share, over \$80 million; and

WHEREAS, such monies would be designated to provide City programs/services not mandated or pass down federal or state programs/services; and

WHEREAS, it is desirable for the City Council to coordinate an effort to rally other cities and counties by writing and calling for support; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Council supports the concept of a Fair Share Initiative, and would recommend to the League of California Cities and other governmental agencies that they support a Fair Share Initiative.

BE IT FURTHER RESOLVED, that Mayor O'Connor is authorized to request the support of the mayors of the cities of California,

and the heads of other governmental agencies, for their support
of a Fair Share Initiative.
