WHEREAS, subsequent to the decision of the Planning Director the City Clerk received several requests for appeals from the case decision from individuals alleging that protection from construction of additional dwelling units is required to prevent exacerbation of parking problems; and

WHEREAS, this appeal was set for public hearing on July 11, 1989, and the Council having considered the matter; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the appeal is hereby granted and the early release from the Single-Family Neighborhood Protection Ordinance is hereby denied.
