RESOLUTION NUMBER R- 273966 ADOPTED ON JUL 111989

WHEREAS, the Council of The City of San Diego through Ordinance No. O-15174 (new Series) adopted January 28, 1980 and Ordinance No. O-15614 (New Series) adopted November 16, 1981 has given the San Diego Fire Department authority to inspect private properties and to cause owners in violation of said ordinances to clean up and remove overgrown weeds, brush and/or rubbish and combustible waste from their properties; and

WHEREAS, the San Diego Fire Department has completed its inspection phase of the 1989 program and has notified affected owners of the existence of hazardous weed and rubbish conditions on their properties; and

WHEREAS, sufficient time and notification have been given to the affected owners between April 19 - June 16, 1989 to successfully perform cleanup operations on their properties; and

WHEREAS, an appeals hearing was held June 27, 1989 to allow affected owners the right to appeal any aspects of the program they felt were not proper; and

WHEREAS, the 1989 phase of the program has inspected 3,700 properties for compliance with the City Weed Abatement Ordinance No. 0-15174 (N.S), and it is estimated that approximately 40 parcels will require abatement by the City; and

WHEREAS, those properties where hazards continue to exist can be abated by the City, provided the City Council adopts a

resolution declaring such property to be public nuisances and ordering the properties to be abated by the City; NOW THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that all of the properties listed in Attachment A, a copy of which is on file in the office of the City Clerk as Document No. RR-273966 not in compliance with City Weed and Rubbish Abatement Ordinance No. O-15174 (N.S.) are hereby declared to be public nuisances.

BE IT FURTHER RESOLVED, that said properties are ordered to be abated by the City pursuant to the provisions of law.
