

RESOLUTION NUMBER R- 273976

RESOLUTION CONSIDERING THE PROTESTS, APPROVING THE MODIFIED MAP, CONFIRMING THE ASSESSMENTS, AND ORDERING THE PROPOSED MAINTENANCE, IN THE MATTER OF THE SCRIPPS-MIRAMAR RANCH LANDSCAPE AND LIGHTING MAINTENANCE DISTRICT.


WHEREAS, the notice of the time and place fixed for the hearing of protests in the matter of "Scripps-Miramar Ranch Landscape and Lighting Maintenance District," under Resolution of Intention No. R- 273583, adopted on MAY 30 1989, having been duly given in the manner required by law and the legal time for filing such protests and the time fixed for hearing thereon having passed; NOW THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. The protests, if any, are overruled.
2. The assessments described in Document No. RR- 273584, on file in the office of the City Clerk and on file in the office of the Street Superintendent, are hereby confirmed and approved.
3. The modified assessment district map for the "Scripps-Miramar Ranch Landscape and Lighting Maintenance District," described in Document No. M-184-1 is hereby approved.

4. The maintenance described in said Resolution of Intention is hereby ordered performed.
