BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of street easement deeds of PHILIP S. OJENA and THELMA M. OJENA, bearing date of April 11, 1989, and of FOOTE DEVELOPMENT COMPANY, a California corporation, dated March 22, 1989, both executed in favor of The City of San Diego, copies of which deeds are on file in the office of the City Clerk as Document Nos. RR-273986-1 and RR-273986-2, granting to said City easements for public street purposes in a portion of Lots 7, 8, 9 and 10, Block 182 of Middletown, and in a portion of Parcels A and B of Parcel Map No. 640, as more particularly described in said deeds, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named HANCOCK STREET.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder at no fee for the benefit of the City, with no documentary tax due.


