BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$150,000 (\$90,000 from Building Inspection Fund 41300 and \$60,000 from Water Revenue Fund 41502), is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
