RESOLUTION NUMBER R- 014001

ADOPTED ON JUN 17 1989

WHEREAS, San Diego Municipal Code section 67.72 provides that minimum water capacity charges may be established by resolution of the City Council upon the giving of ten (10) days notice of intention to establish, amend or increase said charges; and

WHEREAS, San Diego Municipal Code section 64.0404 provides that sewer service charges may be established by resolution of the City Council upon the giving of ten (10) days notice of intention to establish, amend or increase said charges; and

WHEREAS, San Diego Municipal Code section 64.0410 provides that minimum sewer capacity charges may be established by resolution of the City Council upon the giving of ten (10) days notice of intention to establish, amend or increase said charges; and

WHEREAS, said notice of intention has been given by posting in the office of the City Clerk; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That pursuant to San Diego Municipal Code section 67.72, the following minimum water capacity charge is established in all areas of the city except designated redevelopment districts, effective upon the date of passage of this resolution:

A minimum capacity charge of one thousand six hundred and fifty one dollars (\$1,651.00) per single family unit or its

equivalent shall be paid. This charge shall be subject to simple interest of six percent (6%) from the date of passage of this resolution, to and including that date upon which the charge is paid.

In those areas of the City where a capacity charge in the form of area charges as established by Council resolution, or taxation, or special assessment districts (excluding 1911 and 1913 Act Assessment Districts) results in a payment to the City totaling more than the aforementioned charge per single family unit or its equivalent, no new capacity charge shall be imposed by this Section. However, charges imposed due to reimbursement agreements entered into by the City shall be collected where applicable in every case.

That pursuant to San Diego Municipal Code section 64.0404, the following monthly sewer service charges are established, effective upon the date of passage of this resolution:

1. The domestic sewer service charge for each single family dwelling unit serviced by a separate water meter shall be seventeen dollars and twelve cents (\$17.12) per month. These charges shall remain in effect until such time as the City Manager establishes a lifeline rate and sewer service charge, based on water usage applicable to the single family domestic user class, and the further direction of this Council.

2. The monthly sewer service charge for all premises other than single family dwellings serviced by separate water meters shall be seventeen dollars and twelve cents (\$17.12) per month, or a charge per hundred cubic feet of water delivered,

computed in accordance with the following table,

whichever is the greater:

\* Class K shall include all dischargers of wastewater whose discharge exceeds 1,000 parts per million (PPM) of suspended solids. The rate per HCF will be individually computed for dischargers in Class K by first increasing 127.8% by 4.27 percentage points for each 100 PPM by which the discharge exceeds 1,000 PPM, then multiplying the result by the average rate per HCF (\$1.214).

That pursuant to San Diego Municipal Code section 64.0410, a minimum sewer capacity charge is established in all areas of the city except designated redevelopment areas, effective upon the date of passage of this resolution:

A minimum capacity charge of three thousand two hundred and thirty-five dollars (\$3,235.00) per single family dwelling or its equivalent shall be paid. This charge shall be subject to simple interest of six percent (6%) from the date of passage of this resolution, to and including that date upon which the charge is paid.

In those areas of the City where a capacity charge in the form of area charges as established by Council resolution, or taxation, or special assessment districts (excluding 1911 and 1913 Act Assessment Districts) results in a payment to the City totaling more than the aforementioned charge per single family dwelling or its equivalent, no new capacity charge shall be imposed by this resolution. However, charges imposed due to reimbursable agreements entered into by the City shall be collected where applicable in every case.

BE IT FURTHER RESOLVED, that this resolution shall be effective and in force on the date of its passage.
