ADOPTED ON JUL 17 1989

WHEREAS, in FY 1989, the City entered into an agreement with the County under which the County recovers full costs for the provision of general animal control services; and

WHEREAS, it is now desired to extend the effective period of the agreement through June 30, 1990; and

WHEREAS, the estimated cost for general animal control services for FY 1990 is \$1,345,822 and reflects the County's projection for services plus a 10% contingency as required under section 23008 of the California Government Code; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute an AMENDMENT NUMBER ONE TO THE AGREEMENT FOR ANIMAL CONTROL SERVICES, with the County of San Diego, pursuant to the terms and conditions of the amendment on file in the office of the City Clerk as Document No. RR-274015.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized to expend a sum not to exceed \$1,345,822 from the General Fund 100, Non-Departmental

Expenditures (Program 60101) for the above purpose subject to approval of the fiscal year 1990 proposed budget.
