WHEREAS, the City has contracted with the County since 1977 for enforcement of various animal regulation ordinances on beaches and parks; and

WHEREAS, it is now desired to extend the effective date of the agreement through June 30, 1992; and

WHEREAS, the agreement may be terminated by either party upon giving thirty (30) days written notice of intention to terminate; and

WHEREAS, except for exclusion of reference to funding for a motor vehicle in 1987, the terms of the agreement remain the same; and

WHEREAS, the estimated cost for enforcement of various animal regulation ordinances on beaches and parks is \$231,659; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute a SIXTH SUPPLEMENTAL AGREEMENT TO THE BASIC AGREEMENT FOR ANIMAL CONTROL SERVICE, on beaches and parks with the County of San Diego, pursuant to the terms and conditions of the Sixth Supplemental agreement, on file in the office of the City Clerk as Document No. 274017.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized to expend a sum not to exceed

\$231,659 for the above purpose, said funds to come from the General Fund 100, Non-Departmental Expenditures (Program 60101) subject to approval of the fiscal year 1990 proposed budget.
