BE IT RESOLVED, by the Council of the City of San Diego that the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for CONSTRUCTION OF SAIL BAY IMPROVEMENTS - PHASE III, San Diego, California, filed in the office of the City Clerk of the City of San Diego, California, on JUL 24 1989, and bearing official Document No. W.D. 119128/171151, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF SAIL BAY IMPROVEMENTS - PHASE III.

BE IT FURTHER RESOLVED, that the City Auditors and Comptroller is hereby authorized to transfer \$500,000 from the Sail Bay Phase III Grant Fund No. 39032 to CIP No. 22-031.2 SAIL (CRESCENT) BAY DEVELOPMENT, PHASE III.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$1,190,250 from CIP No. 22-031.2 SAIL (CRESCENT) BAY - DEVELOPMENT, PHASE III, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$126,211 from the Sewer Revenue Fund 41506, CIP No. 46-158 MISSION BAY SEWAGE INTERCEPTOR SYSTEM, is hereby authorized solely and exclusively for providing funds for said project and related cost, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
