BE IT RESOLVED, by the Council of the City of San Diego that the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for ALVARADO FILTRATION PLANT - JOINT LABORATORY FACILITY - CONSTRUCTION OF TRAFFIC SIGNAL AT LAKE MURRAY BOULEVARD AND KIOWA DRIVE, San Diego, California, filed in the office of the City Clerk of the City of San Diego, California, on JUL 24 1989, and bearing official Document No. W.O. 170291/180231, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for ALVARADO FILTRATION PLANT - JOINT LABORATORY FACILITY - CONSTRUCTION OF TRAFFIC SIGNAL AT LAKE MURRAY BOULEVARD AND KIOWA DRIVE.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$175,750 (\$105,450 from the Sewerage Revenue Fund 41506, CIP No. 46-124 ALVARADO FILTRATION PLANT - JOINT LABORATORY FACILITY and \$70,300 from the Water Revenue Fund 41502, CIP No. 73-258 ALVARADO FILTRATION PLANT - JOINT LABORATORY FACILITY), is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
