



BE IT RESOLVED, by the Council of The City of San Diego, that the expenditure of an amount not to exceed \$124,991.00 from Gas Tax Fund 32191, C.I.P. 37-028, Annual Allocation, Undergrounding of City Utilities, is hereby authorized, solely and exclusively, as payment to San Diego Gas and Electric Company for the purchase and installation of thirty-four (34) new street lights to replace existing pole mounted street lights in the Rosecrans Street (Canon Street to Tennyson Street) Underground Utility District.
