

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to issue one check in the amount of \$200,000.00 made payable to Jeffrey Dickenson and his attorney John Metz in full settlement of the lawsuit and of all claims.
