WHEREAS, Barry Wagner is trained in rescues involving crashed military aircraft; and

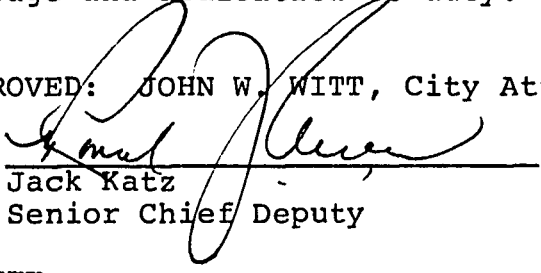
