RESOLUTION CONSIDERING THE PROTESTS, APPROVING THE MODIFIED MAP, CONFIRMING THE ASSESSMENTS, AND ORDERING THE PROPOSED MAINTENANCE, IN THE MATTER OF THE NORTH CITY WEST LANDSCAPE AND LIGHTING MAINTENANCE DISTRICT.
