RESOLUTION CONSIDERING THE PROTESTS, APPROVING MODIFIED MAP, CONFIRMING THE ASSESSMENTS, AND ORDERING THE PROPOSED MAINTENANCE, IN THE MATTER OF THE LOPEZ CANYON STORMWATER RETENTION BASIN MAINTENANCE DISTRICT.

3. The modified assessment district map for the "Lopez Canyon Stormwater Retention Basin Maintenance District," described in Document No. M-197-1 is hereby approved.
