RESOLUTION CONSIDERING THE PROTESTS, APPROVING MODIFIED MAP, CONFIRMING THE ASSESSMENTS, AND ORDERING THE PROPOSED MAINTENANCE, IN THE MATTER OF THE SAN YSIDRO BOULEVARD LANDSCAPE MAINTENANCE DISTRICT.
