WHEREAS, on January 13, 1988, the California Coastal Commission certified with suggested modifications The City of San Diego Local Coastal Program (LCP) Implementation Plan; and

WHEREAS, on April 5, 1988, the Council of The City of San Diego accepted the California Coastal Commission's certification of the City's Local Coastal Program Implementation Plan, with modifications; and

WHEREAS, the La Jolla Planned District Ordinance constitutes an amendment to the Local Coastal Program Implementation Plan; and



BE IT FURTHER RESOLVED, that the Planning Director is authorized and directed to transmit this Local Coastal Program Implementation Plan amendment for the La Jolla Planned District Ordinance to the California Coastal Commission for their final and effective certification.

BE IT FURTHER RESOLVED, that this local coastal program amendment shall become effective upon final and effective certification by the California Coastal Commission.
