BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the second low bid of \$1,057,561 by DORFMAN CONSTRUCTION COMPANY, INC., a corporation, meeting specifications for CONSTRUCTION OF SEWER MAIN REPLACEMENT GROUP 61, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefore in accordance with the form on file in the Office of the City Clerk as Document No. 147139.

2. That the expenditure, not to exceed \$309,000 from Sewer Revenue Fund 41506, to supplement funds previously authorized by Resolution No. 273038, adopted March 20, 1989 is hereby authorized solely and exclusively for said project and related costs and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
