

RESOLUTION NUMBER R-274121

ADOPTED ON JULY 31, 1989

BE IT RESOLVED, by the Council of The City of San Diego, that the Council hereby adopts the SAN DIEGO COUNTY HAZARDOUS WASTE MANAGEMENT PLAN (the "Plan"), a copy of which is on file in the office of the City Clerk as Document No. RR- 274121-1.

BE IT FURTHER RESOLVED, that the City Manager and the City Planning Director are directed to prepare for Council action, subject to the approval of the San Diego County Hazardous Waste Management Plan by the State Department of Health Services, the various methods for complying with the major plan recommendations, including but not limited to the following:

1. Preparation of a policy for adoption by the Council to consider the data, policies and recommendations of the San Diego County Hazardous Waste Management Plan in evaluating applications for facility siting;

2. Adoption of the siting criteria contained in the San Diego County Hazardous Waste Management Plan for use in evaluating facility applications;

3. Use of the general area identified within the San Diego County Hazardous Waste Management Plan as a basis for accepting facility applications and the siting thereof;

4. Adoption of the model conditional use permit, or other equivalent procedural means, for processing and evaluating facility permits;


5. Consideration of the approval and use of the Southern California Hazardous Waste Management Plan and intergovernmental agreements and incentives programs in evaluating applications in facility siting.

BE IT FURTHER RESOLVED, that the Council hereby authorizes its Council Representative to the Southern California Hazardous Waste Management Authority, the Honorable Gloria McColl, or, in the alternative, Mr. George Story if Ms. McColl is unable to attend, to vote in favor of the adoption of the Southern California Hazardous Waste Management Plan, a copy of which is on file in the office of the City Clerk as Document No.

RR-274121-2 and to further restate the Council's support of the "fair share" concept applicable to the siting of hazardous waste facilities.
