BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$1,019,951.00, consisting of \$254,102.00 from the Water Revenue Fund No. 41502, Water Systems Construction Program, Annual Allocation for Water Main Replacements, CIP No. 73-083, and \$756,849.00 from the Sewer Revenue Fund No. 41506, Wastewater Systems Construction Program, Annual Allocation for Sewer Main Replacements, CIP No. 44-001, is hereby authorized, solely and

exclusively for the purpose of providing funds for the above improvements.
